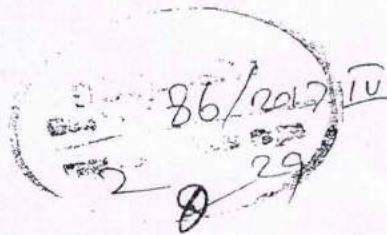

**NOW THIS INDENTURE WITNESSETH AS FOLLOWS:-**

**1. CREATION OF TRUST**

That in order to fulfill the said object of the creating and establishing a Public Charitable Trust, the settlor has delivered to and made over to the Trustees a total sum of Rs.5,101/- (Rupees Five Thousand One Hundred and One only) with intent to part with all his rights, title and interest/claim therein and vest the same in the First Trustees to have and to hold the same and the investment or investments for the time being representing the same for the Charitable objects and purposes and uses herein after expressed with the powers and on terms and conditions herein - contained of and concerning the same, and whereas the Trustees hereby agree and declare to hold the said sum of Rs.5,101/- (Rupees Five Thousand One Hundred and One only) either towards the Corpus or for expenses of the purposes mentioned below.

**2. NAME OF THE TRUST**

The name of the Trust shall be "SHRI. R K SINGH MEMORIAL EDUCATIONAL & CHARITABLE TRUST".

**3. OBJECTS OF THE TRUST**

The office of the Trust shall be situated at 9/12 Gandhi Nagar, G N Mills Post, Coimbatore -641029 which may be moved from time to time to such other place or places as the Board of Trustees may deem fit and proper at their discretion.

3.1 To open, fund, establish, promote, set-up, run, assist, maintain, repair, finance, support and /or aid or help in the setting up of or maintaining or running of schools, colleges, universities, research institutes, lecture halls and other institutions for advancement of education and of knowledge in art, science, literature, humanities, culture and all other useful subjects in all their manifestations including the establishment and maintenance of training and vocational institutes, Kala Kendra's etc.

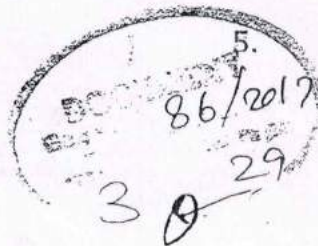

3.2. To grant, pay or give scholarships, stipends, prizes, rewards, allowance and other financial assistance or help in cash or in kind to students with a view to help them in pursuing their studies in schools, colleges, educational institutions, technical institutions, art schools, research centers, etc.

3.3 To evolve systems of educational outreach programmes in rural and in urban areas where clusters of low income groups exist.

3.4 To improve quality education by preparation and usage of innovative learning material and adopting scientific teaching, techniques and technologies through remedial education classes. To create opportunities of imparting moral education for enculturation of the student so as to make them responsible and faithful citizens of the nation.

3.5 To give, provide and/or render help and assistance in cash or in kind or in any shape or form and/or implement any scheme for providing for livelihood and social upliftment of the poor, deserving destitute people etc, and also to conduct, organize or provide monetary help to poor and arrange for feeding of the needy.

3.6 To open, fund establish, promote, set-up, run, maintain, assist, finance, support and /or help in the setting up of or maintaining or running hospitals, dispensaries, maternity homes, child welfare centers, convalescent homes, sanatoriums, yoga and meditation centers and other similar institutions / centers rendering or providing medical relief and / or aid to the suffering humanity or for research centers and institutions for promotion of research and education for medical science including surgery, native and all systems of medicines

3.7 To give relief to affected by natural and other calamities, such as flood, fire, famine, cyclone, earth-quake, storm, accident, pestilence, draught, epidemic, unbearable cost of living and the like, to give donations, subscriptions or contributions to institutions, establishments, centers or persons doing relief work on such occasions or purposes.

3.8 To promote, organize, administer, establish, support, maintain and or grant aid to any person, institution or society or organization whatsoever having for its objects of charitable purposes.

3.9 To hold, and/or support organization of any camps, conferences, events, seminars, exhibitions or otherwise publicize in any manner found convenient for raising funds for the spread or advancement or achievement of the objectives of the Trust.

3.10 To extend the benefits under the objects of the Trust for the people for education, health, medical needs or any other charitable cause without any disparity or discrimination by way of religion, caste, creed or sex.

3.11 To acquire any rights, title or interest in any property or rights or easements connected thereto by purchases, lease, hire, exchange, or otherwise, to accept lands, buildings, funds, donations, gifts, endowments or any property conditionally or for a limited purpose or period in furtherance of the objects of medical and / educational as set out in clause 3.1 to 3.9 above. The Trustee may allow any donor to construct a building on any land forming part of the Trust for being used for purpose of any of the aforesaid charitable objects and purposes set out in clause 3.1 and 3.2 above. All such contributions and donations including buildings shall form part of the Trust Fund and be applied accordingly, provided that it shall always be for the Trustees in their absolute discretion to decide whether they should invite or accept any such contributions or donations and they shall at all times be at liberty to refuse any contributions or donations without assigning or giving any reason for such refusal.

**4. INVALID OBJECTS**

If any one or more of the Objects specified in the above clauses of these presents are held not to be Objects of a public charitable nature under the Income -tax Act, 1961 or any other applicable law for the time being in force, the Trustees shall not carry out such object or objects as if the same are not incorporated in these present, but the validity of the Trust created by these presents as a Trust for public charitable purpose shall not be affected in any manner.

All activity under any of the objects mentioned above shall be undertaken or carried out in India.

**5. BOARD OF TRUSTEES**

5.1 The Board of Trustees shall consist of a minimum of 2 (Two) and maximum of 7 (Seven) Trustees including any co-opted Trustee/First Trustees.

5.2 The first trustees shall co-opt the balance trustees so as not to exceed 7 trustees in all.

5.3 From among the first trustees, U.N.Singh shall hold office for his life time. The other trustees among the first trustees of the Trust shall hold office for a period of two years, unless a Trustee resigns or otherwise ceases to be a Trustee under the provisions of Clauses 5.15 below.

a) On expiry of the period of Two Years from the date of execution of this Trust Deed, of the First Trustees, other than life trustee, two trustees will retire from office. Thereafter every Bi-annual (that is every two years ending) two shall retire from the office, that the Trustees to retire shall be those who have been longest in the office since their appointment. But as between the Trustees who became members of the Board on the same

day, in default of agreement or consensus among themselves, shall among themselves be determined by lot, that the vacancies so arising shall be filled up by the Board of Trustees from among the retiring trustees or any other person who shall hold office for a period of two years and shall retire after expire of two years as provided herein before.

b) The remaining Trustees, including the co-opted Trustees, shall retire Bi-annually, that is at the end of the two financial years of Trust. The retiring trustees shall, however, be eligible for re-appointment.


5.4 If any vacancy arises for any reason, the vacancy so arising may be filled up the Board by co-option and such co-opted Trustees shall hold office for a period coinciding with the close of the bi-annual years of the Trust.


5.5 The surviving or continuing Trustees may notwithstanding any vacancy in the Board act as Trustees, provided however, that if the number of Trustees fall below of two the minimum fixed by these presents, the Trustees shall not, except for the purpose of any filling-up vacancy, act so long as the number is below the said minimum


5.6 Two Trustees at a Meeting shall form a quorum for any meeting of the Board of Trustees.


5.7 Sri. U N Singh from among the First Trustees be the First Chairperson of the Board of Trustees and he shall continue to hold office for his life time unless he resigns or refuses to act as Chairperson or vacates office as Trustee. After expiry of the term of the First Chairperson, subsequent Chairperson shall be elected from among the Trustees for a term of two years by the Trustees then holding office.

5.8 All proceedings and questions and matters arising at the meetings of the Board of Trustees shall be decided by majority of votes, and in case of equality of votes, the Chairperson shall have second or casting vote.

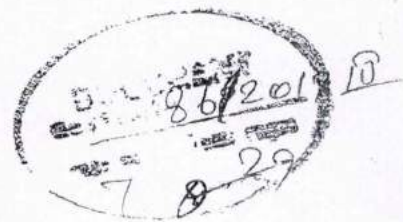

5.9 Notice of three days in writing of all Meetings of the Board of Trustees and all communications may be sent to the Trustees at their address registered for the time being in the records of the Trust. In case of any emergent situation if a meeting is considered necessary, other mode of communication such as Telephone, Mobile Phone, SMS, E-mail etc. may be deemed sufficient for convening any such meeting by the Chairperson.

5.10 All Meetings of the Board of Trustees shall be held at such place and at such time as the Chairperson of the Trust shall decide from time to time. The Board of Trustees shall meet at least once in every three months.


5.11 A Trustee who is unable to attend or present at a Meeting of the Board of Trustees may send his views on the agenda in writing and such expression of opinion shall be taken for consideration and discussion without counting for voting.


5.12 The Minutes of all the proceedings of every meeting of the Board of Trustees shall be entered in a Minutes Book to be kept for that purpose and signed by the Chairperson of such meeting at the following meeting when they are read over and shall when so entered and signed be conclusive evidence of the business and other matters transacted at such meeting. 



**6. DISQUALIFICATION TO BE A TRUSTEE**

A person shall cease to be a Trustee in any of the following events:-

- If he/she dies, or
- If he/she becomes bankrupt, or
- If he/she becomes insane or otherwise becomes incapable to act, or

If he/she resigns his office or ceases to be a member of Board of Trustees for any reason.


**7. POWERS OF THE TRUSTEES**


Without prejudice to the generality of the powers and functions of the Trustees to manage and administer the Trust, the Trustees shall have the following powers and functions:-


7.1 To borrow, if needed, against the security of the assets of the Trust or without security by way of Bank overdraft, loan or otherwise, or accept any deposits or loan from any person, as may be necessary, for the benefit of the Trust and for more effectively carrying out the objectives of the Trust, and to authorize two or more of the Trustees including the Chairperson for the time being to execute such documents, deeds, papers, etc, as may be necessary in connection therewith.

7.2 To arrange for and/or authorize the signing or execution of any mortgages, charges or encumbrances, agreement, contract, instrument, document or any other paper or writing required to be signed or executed on behalf of the Trustees by any two of the Trustees to be nominated in this behalf.






7.4 To spend any portion of the Corpus or the income of the Trust Fund for purchasing any land or constructing any building or buildings for and in the name of the Trust for the purpose of carrying out, promoting and // or executing any or all of the objects of the Trust.



7.5 The Board of Trustees may rent, lease, purchase, receive donations in kind or otherwise acquire for the purpose of the Trust any movable or immovable properties including lands, buildings, automobiles and other vehicles, furniture, machines and appliances, or any other physical objects whatsoever. The acquisition of immovable property shall be only for objects of the trust.

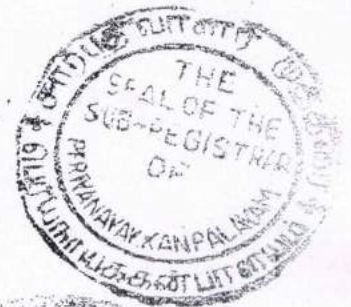
7.6 The Board of Trustees shall cause true and correct accounts to be kept of all moneys received and spent, and of all matter in respect thereof in the course of management of the Trust properties or in relation to the carrying out of the objectives and purposes of the Trust as well as the assets, credits and effects of the Trust properties.

7.7 The Board of Trustees may invest the Trust Estate or fund either in the purchase of immovable properties or of mortgage properties, securities in such manner as allowed under Income-tax Act, 1961 or any other law as may be in force from time to time and to convert, alter, vary, dispose of or transfer such investment from time to time provided that such investment shall not be made which are directly or indirectly for the benefit of any person and particularly persons provided in section 13 of the Income -tax Act, 1961 or any amendment thereto above.

7.8 If the income from the trust in a particular year is not fully utilized, the unspent income subject to the applicable provisions of the Income-tax Act, 1961 or its reenactment thereof, shall be carried over to the next year or years and spent in such subsequent year or years for the advancement of any of the objects of the Trust. Likewise, any deficit arising out of excess of expenditure over income may be carried over to subsequent year/s and adjusted against income in any subsequent years.

7.9 The Board of Trustees shall be at liberty to sell or give on lease/ rent such portion or portions of the movable or immovable properties forming part of the Trust Estate either by public auction or by private contract at such price and in such terms and conditions relating to title or otherwise in all respect as they may in their absolute discretion think fit and to rescind or vary any contract for the sale thereof and to resell the same without being answerable for any loss occasioned thereby and to execute all conveyances or other assurances and to pass valid and effectual receipts and discharge for all moneys received by them.

7.10 To open, keep an account/s with any bank/s and to operate such account or accounts whether in debit or in credit and to give all appropriate instructions to the Banker or bankers concerning the operation of such account/s and to authorize by appropriate resolution the treasurer with one or more of the Trustees jointly or with an agent appointed by the Board of Trustees in this behalf to operate such account or accounts.

7.11 To pay all charges and outgoings in respect of any immovable property for the time being forming part of the Trust Fund and to carry out repairs required to be done to the same and keep the same insured against loss or damage by fire and any other eventuality and may incur all costs, charges and expenses incidental to the administration of the Trust Estate and the properties for the time being belonging to the Trust as they may in their absolute discretion think fit and proper.

7.12 To appoint secretaries, managers, lawyers, solicitors, auditors, architects, engineers, surveyors or other employees for the purpose of management and supervision of the Trust Estate, for collection of rent for keeping the accounts and records and for other purposes of the Trust.

7.13 To have full powers to compromise or compound all actions, suits and other proceedings and settle differences and disputes touching the Trust Estate and or the Trust properties and to refer any differences or disputes for arbitration and to adjust and settle all accounts relating to the Trust Estate and the Trust properties and to do all other acts.

7.14 To join, cooperate and amalgamate the Trust created by these presents or any portion thereof with any trust or institution having allied and or similar objects which enjoy recognition under the Income-tax Act,1961, as amended from time to time, on such terms as they may in their absolute discretion think fit and proper.

7.15 The receipts granted by the Trustee authorized to do so on behalf of the Trust for any money's stocks, funds, shares, securities, or investments paid, delivered or transferred to them in exercise of the Trust or powers thereof shall effectually release and discharge the persons or persons paying, delivering, or transferring the same therefrom and from seeing or from being bound to see to the application thereof or being answerable for the loss or misapplication thereof.

7.16 The Board of trustees shall be entitled at their discretion from time to time to start, discontinue, abolish and restart any charity or charitable institution, to impose any condition or conditions to any subscription or donation made by them and to earmark any portion of the Trust property or income for any particular object/s.

7.17 To reimburse, to any Trustee and pay and discharges out of the Trust fund all expenses incurred by him in or about the execution of the object of the Trust or any of the duties under these presents including traveling expenses, but, a Trustee will not be entitled to any remuneration, share of profit or any other payment by whatever name called.

**8. ANNUAL ACCOUNTS**

8.1 The financial year of the Trust shall be the year ending on the 31<sup>st</sup> March of every year.

8.2 The Board of Trustees shall be at liberty to change the financial year from time to time if they so deem it fit and proper.

8.3 The Trust Board shall cause to be maintained True and correct day to day accounts of the receipts and payments and incoming and outgo of amounts with proper vouchers and supporting evidences and preserve them properly and systematically.




**9. TAKE OVER OF OTHER INSTITUTIONS**



**10. AMENDMENT OF THE DEED OF TRUST**

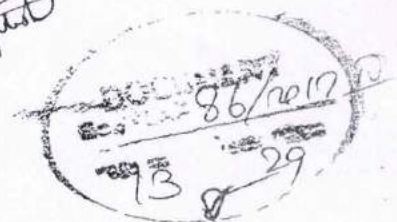
